## PART 8 – LAOIS COUNTY COUNCIL DEVELOPMENT OF PARKING FACILITIES, ROCK OF DUNAMASE, AGHNAHILY, DUNAMASE, PORTLAOISE, CO. LAOIS.

In accordance with Part XI, Section 179 of the Planning and Development Act 2000 as amended and Part VII article 80 and 81 of the Planning and Development Regulations 2001 as amended notice is hereby given that Laois County Council propose to construct a car park at the Rock of Dunamase, Portlaoise, Co. Laois.

The proposed development will include the following:

- 1. 44 Car Parking spaces including Disabled Parking spaces.
- 2. 4 Bus Lane Parking Bays
- 3. Bicycle Stands
- 4. Picnic Area
- 5. Provision of traffic safety measures and signage to facilitate safe access
- 6. Landscaping

Laois County Council has prepared an EIA Screening Report in accordance with the requirement of the Planning and Development Regulations 2001 (as amended) within which it has been determined that there is no likelihood of significant effects on the environment. (Article 120 of Planning and Development Regulations, amended 2018).
