## Portarlington Permeability Schemes 2023

## Scheme 01- Ballymorris Road to Canal Road, Portarlington, Co. Laois.

In accordance with Part XI, Section 179 of the Planning and Development Act 2000 as amended and Part VII article 80 and 81 of the Planning and Development Regulations 2001 as amended, notice is hereby given that Laois County Council propose to develop permeability improvements from Ballymorris Road to Canal Road, Portarlington, Co. Laois.

The proposed development will include the following:

- 1. Segregated pedestrian and cyclist infrastructure in Clanmalire Close, Whitefields, Canal Court, Ballymorris Court, Castlegate, Corrig Glen Apartments and access road adjacent Lidl supermarket.
- 2. Removal of existing boundaries to create pedestrian/cycle linkages between:
  - a. Ballymorris Court and Canal Court
  - b. Clanmalire Close and Whitefields
  - c. Whitefields and Castlegate
  - d. Corrig Glen apartments and Lidl supermarket
- 3. Road junction improvements at Station Road/Whitefields/Corrig Glen junction and Canal Road/Lidl access road junction.

Laois County Council has prepared an AA and EIA Screening Report in accordance with the requirement of the Planning and Development Regulations 2001 (as amended) within which it has been determined that there is no likelihood of significant effects on the environment. (Article 120 of Planning and Development Regulations, amended 2018).
