Portarlington Permeability Schemes 2023

Scheme 02 - Bracklone Street to Canal Road, Portarlington, Co. Laois.

In accordance with Part XI, Section 179 of the Planning and Development Act 2000 as amended and Part VII article 80 and 81 of the Planning and Development Regulations 2001 as amended, notice is hereby given that Laois County Council propose to develop permeability improvements from Bracklone Street to Canal Road, Portarlington, Co. Laois.

The proposed development will include the following:

- 1. Segregated pedestrian and cyclist infrastructure in St. Brigid's Square and Arlington Estate through the provision of:
 - a. Reduced carriageway widths
 - b. Formalised car parking bays
 - c. Traffic calming measures
- 2. Formalisation of existing pedestrian/cycle link from Arlington Estate to Canal Road (adjacent AVON lands)
- 3. Road junction improvements at Bracklone Street/St Brigid's Square junction.

Laois County Council has prepared an AA and EIA Screening Report in accordance with the requirement of the Planning and Development Regulations 2001 (as amended) within which it has been determined that there is no likelihood of significant effects on the environment. (Article 120 of Planning and Development Regulations, amended 2018).
